2. Fake Registrations Drive in GST



Hon'ble Union Finance Minister Smt. Nirmala Sitharaman, took a comprehensive review of the ongoing efforts to combat fraudulent invoicing for GST evasion. The session was attended by Mr. Sanjay Malhotra, Revenue Secretary and Mr. Vivek Johri, Chairman of the Central Board of Indirect Taxes and Customs (CBIC). The Finance Minister received a detailed briefing on the actions taken against counterfeit registrations, with a staggering 11,140 such instances already identified and corresponding measures initiated. The Finance Minister was apprised of the methods being adopted like identity theft of people. She

acknowledged the existing measures being undertaken by the ministry, including OTP based verification of Aadhar and pilot of biometric-based Aadhar authentication at the time of registration in high-risk cases. The Revenue Secretary and Chairman, CBIC highlighted the extensive use of AI/ML tools to identify potential fake networks. The Finance Minister emphasized the need to bolster the GST registration process using technology to prevent the entry of fraudulent entities into the GST ecosystem. Additionally, she called for a nationwide campaign to explain the objectives of the special drive to weed out fake entities.

CBIC chief Vivek Johri said that the tax authorities are also discussing some more tightening in the GST return filing system to limit the scope of claiming Input Tax Credit (ITC), when suppliers in the supply chain have not paid taxes. The biometric authentication of authorised representatives or directors or partners of a company will be made for new registration applications and existing businesses registered under Goods and Services Tax (GST) if tax officers have a suspicion that the entities are being set up only to fraudulently claim ITC. The CBIC chief further said that during the ongoing drive against fake registration, GST officers have identified around 12,500 bogus entities, which were used to claim fake ITC and defraud the exchequer.

Certain parts of Gujarat, Noida, Kolkata, Assam, Telangana, Tamil Nadu and Maharashtra also have fake businesses with GST registration. Sectors, in which fake entities are, include metal or plastic scrap and waste paper. "We are also finding that it is being generated for services. So, manpower services and advertising services have instances of fake billing, Johri added. With regard to controlling fake ITC claims, Johri said the tax authorities have tightened the system but there is still some latitude for taxpayers to edit how much ITC they will be able to claim in GSTR-2A. That is there because concerns were raised by trade the supplier doesn't upload invoices on time, and there are some invoices for which they have already made the payment, but they are not able to take credit because they are not uploaded, he added. "We have allowed some editing facilities. We will see how we can tighten that so that the scope for passing certain ITC is reduced," Johri added. The GST Council, comprising finance ministers of the Centre and states, has already taken a number of steps, including the sequential filing of monthly returns, to curb fake ITC in the system.

3. One in every 10 retail borrowers missing monthly payments



According to RBI's financial stability report, the total of SMA-0, SMA-1 and SMA-2 in the retail advances in the public sector banks was 9.4% as of March 31. Even as the gross bad loans in India are at a decadal low of 3.9 per cent, nearly 10 per cent of retail borrowers are missing their monthly payments, the financial stability report (FSR) released by the Reserve Bank of India (RBI) recently showed.

The inflation surge had a cascading effect on borrowers from all walks of life. Let us explore how different types of borrowers were affected:

1. Homeowners and Mortgage Borrowers:

As the cost of living soared, borrowers found themselves stretched thin financially. Homeowners and mortgage borrowers were especially vulnerable to defaulting on their loans, as they struggled to meet their monthly mortgage payments. Many found themselves trapped in homes with negative equity, making it impossible to sell or refinance to ease their financial burden.

2. Small and Medium Enterprises (SMEs):

SMEs, which form the backbone of India's economy, faced tremendous challenges amid soaring inflation. These businesses typically rely on loans for expansion, working capital, and day-to-day operations. However, with the cost of raw materials and production increasing, SMEs found it challenging to generate enough revenue to service their debts. This led to a rise in defaults and closures of several small businesses across the country, exacerbating the already grim employment situation.

3. Credit Card Holders and Personal Loan Borrowers:

Consumers with credit card debt and personal loans were also severely impacted. The rising inflation resulted in a significant increase in interest rates, making it even more difficult for these borrowers to repay their outstanding balances. Many individuals were forced to prioritize essential expenses like food and housing, leading to a growing number of defaults on unsecured debt.

The loan accounts falling under SMA-1 and SMA-2 have a higher proclivity for default. "Although the gross non-performing ratio of retail loans at the system level was low at 1.4 per cent as of March 2023, the share of 'special mention accounts' was relatively high at 7.4 per cent for scheduled commercial banks (SCBs) and it accounted for a tenth of their retail assets portfolio," RBI said in the report. The statistic gains more importance given that the pace of retail loans between March 2021 and March 2023 has doubled compared to the total advances. Moreover, the RBI said that high inflation puts the repayment of these loans for many retail investors at risk. The report also showed that there is potential stress on household balance sheets. "Households with an EMI-to-income ratio of more than 60 per cent are more at risk of a negative financial margin," it said. Financial margin is defined as income net of estimated taxes, EMI on household loans and expenditure on necessities. High inflation increases the expenditure on necessities. In addition, the rate hikes by the central bank increase the EMIs, impacting the margins of households. Since April last year, the repo rate has gone up 250 basis points to 6.5 per cent from 4 per cent. According to several economists, the rate cuts are at least two quarters away.
